

PATRICK THOMAS MALONE (1843-1928)

Patrick Thomas Malone was born at or near Goulburn on 21st March 1843.

Patrick Thomas Malone was the son of:

- ✓ an Irish convict father Patrick Malone from Swords Parish, Dublin, Ireland and
- ✓ an Irish immigrant mother, Mary Carey from Cahir, Tipperary, Ireland.

When Patrick Thomas Malone was born, his parents were most likely living at James Chisholm's (2nd) Goulburn property "Kippilaw".

Patrick Thomas Malone was baptised just over 3 years after his birth, at St. Peter and St. Paul's Catholic Church at Goulburn by Father Michael Brennan on 27 July 1846.

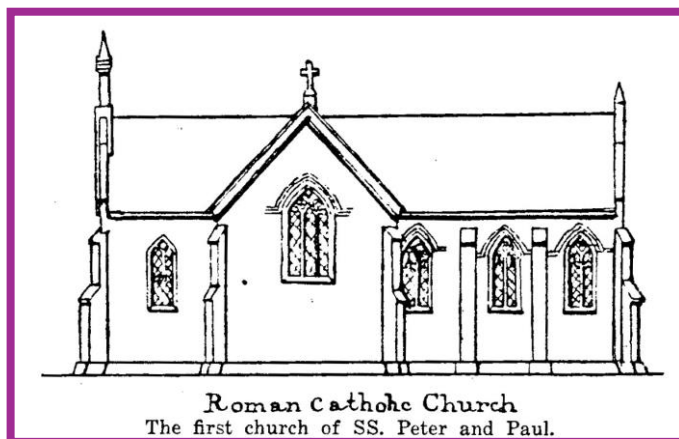
Attending the baptismal ceremony were Thomas and Annie Field who acted as sponsors.

Patrick's sister Mary Malone (Mary Catherine Malone) was baptised on the same day, 27 July 1846.

Mary Catherine Malone was baptised just a year after her birth. Mary Catherine Malone was born on 8 June 1845, the birth location Fish River (*possibly on a Chisholm family property near the present day township of Gunning*).

Attending Mary's baptismal ceremony were Alex Ahy and Maria Connor who acted as sponsors.

Death of Convict father - PATRICK MALONE

Patrick Thomas Malone was to know little of his father, because when aged **4 years**, his father Patrick Malone was to die at Goulburn Hospital at the very young age of 35 years. The year was 1847 and Patrick Malone had arrived in the Colony of New South Wales just 11 years earlier via the convict ship "Hero" in 1835.

When Mary Malone re-married at St Saviour's Church in Goulburn on 21 July 1849, Patrick Thomas Malone was to gain a step-father in **Joseph Jones**.

Joseph Jones had also been a convict, arriving in the Colony of New South Wales per the ship "John" (4) on 7 February 1837.

Joseph Jones was assigned as a convict to **James Kinghorne** of Goulburn, the **brother of Elizabeth Kinghorne** who was the wife of **James Chisholm (2)**. It was the Chisholm family with whom Patrick Malone had been assigned as a convict.

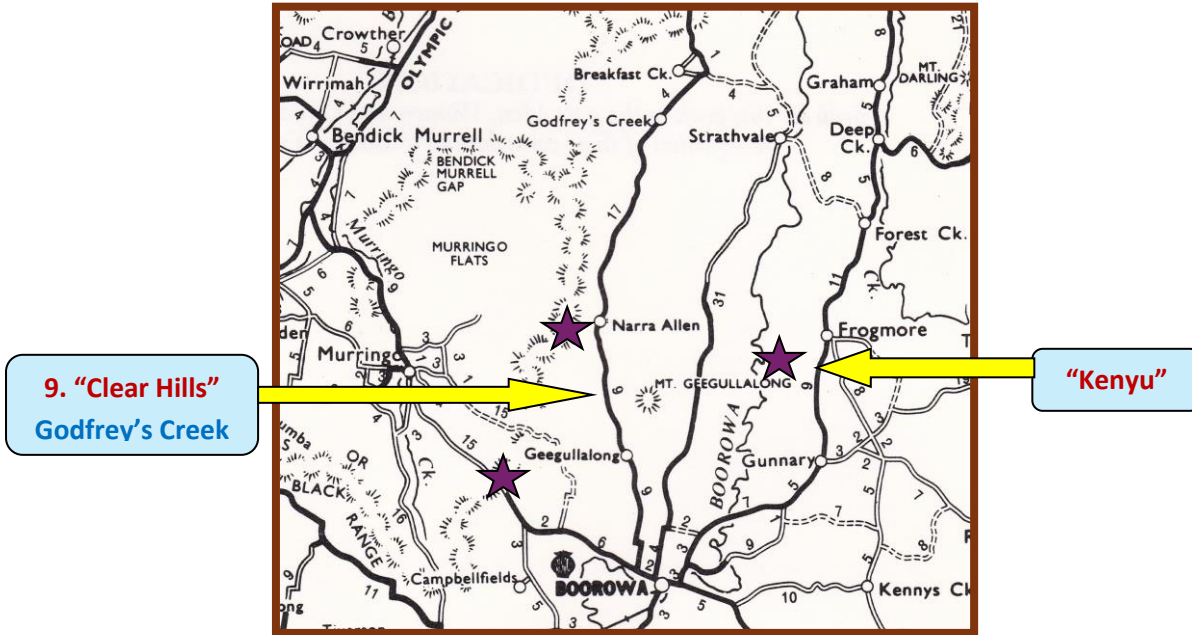
PATRICK THOMAS MALONE – *moving further inland!*

Little is known of Patrick Thomas Malone's early life in the Goulburn area, but when his mother died in 1867, in witnessing his mother's death certificate, he indicated that he was residing at "*Clear Hills*". Patrick Thomas was then just 24 years of age.

There were a number of properties named ★“Clear Hills” appearing on maps between Goulburn and Frogmore/Boorowa area including on a map above, taken from Mary Durack’s ‘best seller’ Kings in Grass Castles”.

However, I believe the most likely ***“Clear Hills”*** property is the one located close to the more familiar properties associated with Chisholm family.

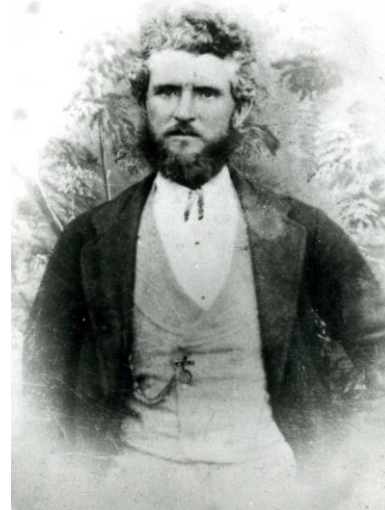
The property “**Clear Hills**” at Godfreys Creek is near localities associated with the Chisholm family such as: ‘*Kenyu*’, ‘*Gegullalong*’ and ‘*Narrallen*’



An extract from an obituary document stated: “When Patrick Thomas Malone transferred to the Boorowa area in 1864 to work for the Chisholm Brothers at “Kenyu”, he was to be welcomed by his half-brother John Jones who was overseer of the station at that particular time.

Patrick Thomas Malone – ‘Kenyu’

Patrick Thomas Malone continued to work at ‘Kenyu’ until 1874 when the “Occupation Lease” for ‘Kenyu’ was purchased by Jenkin Morgan and family from the Chisholm brothers.

The Chisholm’s had decided to extend their vast pastoral interest into the West Wyalong area on the property ‘East Bland’.

At “Glenavon”, a neighbouring property and part of the original “Kenyu” Station lived Jenkin and Mary Morgan and family, which included their young 18 year old daughter **Sarah Morgan**.

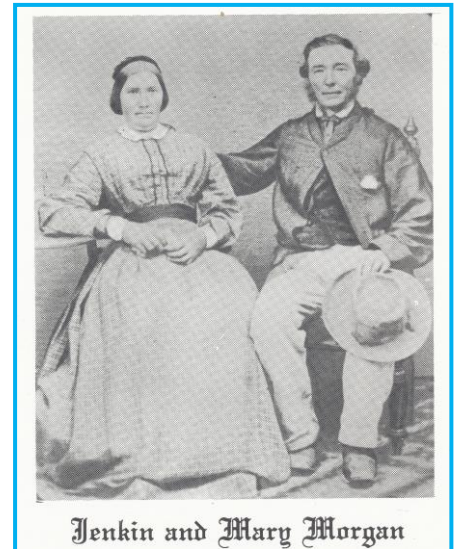
Morgan Family – Welsh Bounty Immigrants

Welsh Bounty Immigrants Jenkin and Mary Morgan, along with their eldest son David Morgan arrived in the Colony of New South Wales per the ship ‘Orient’ on 16 January 1841.

Jenkin was a skilled carpenter and the family gained employment with the Chisholm family at ‘Kippilaw’, Goulburn.

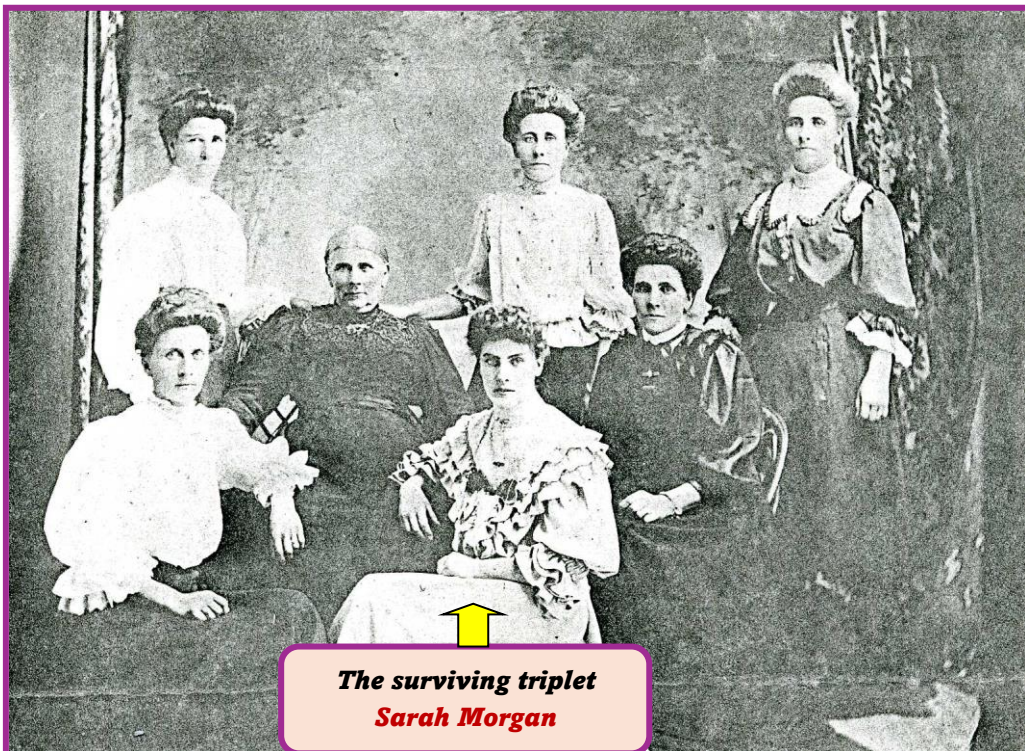
A further seven children were born in the Goulburn area before the family moved towards the Boorowa / Frogmore area where the Chisholm family had expanded their pastoral landholdings.

When Joseph Morgan (child number 9) was born on 13 July 1851, the Morgan family had moved to the Boorowa / Frogmore area and had employment links to properties such as ‘Gegullalong’, ‘Narrallen’ and ‘Kenyu’.



At the property ‘Narrallen’ on 21 June 1856, Mary and Jenkin Morgan were to welcome the birth of triples. But all was not well as the triplets were set aside in shoeboxes, all presumed dead.

A very long and arduous horseback by a doctor from Yass had a successful outcome as **one** of the triplets had **survived the birth**.



Patrick Thomas Malone - Frogmore

After leaving the employ of Kenyu Station in 1874, it is believed that Patrick Thomas Malone moved to the village of Frogmore.

The Frogmore Copper Mine appears to have been in existence for a number of years before the Frogmore Copper Company came into existence as is reported in *The Burrowa News, Saturday 7 April 1877*

Frogmore Copper Mine. — *About ninety men are now employed at Messrs. Deer Brothers' mine, the working operations at which are being proceeded with vigorously. The main shaft is now down to a depth of 274 feet, and the ore being raised is described as very good.*

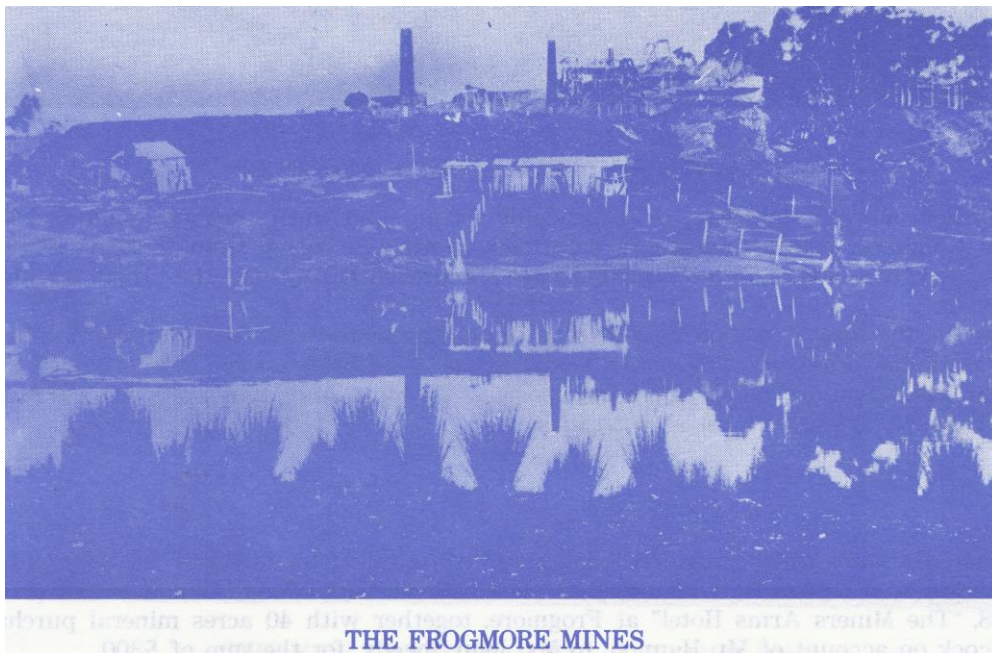
There are three furnaces, all of which are kept constantly going.

*In Mr. Sheedy's paddock, where the work is carried on under the superintendence of Captain Wills, about 40 men are at work, some of them on **tribute**. {The mine was worked under the **tribute system**, where a large mining company having extracted all the easily won mineral, would lease their mine to a smaller third party}.*

In one of the tribute shafts (Richard Scott and party's) a splendid lode was recently struck. The lode is now, at a depth of 90 feet, about 4 feet 6 inches wide; and the ore brought to the surface is admitted to be the best yet seen at Frogmore.

There is one furnace in this paddock; and it is intended, we believe, to erect another very shortly.

Frogmore Copper Mine

The NSW Government Gazette Listing of Friday, 11 November 1881, lists the formation of the Frogmore Copper Company under the management of Eynon Deer, the major shareholders being Eynon, John and James Thomas Deer (Deer Brothers).

The nominal capital of £10,000 was made up of 1,000 ten pound (£10) shares.

Patrick Malone - Frogmore Races

The Burrowa News, Saturday 7 April 1877, reports on the Frogmore Races, where horse owner and jockey Patrick Malone is featured in his moment of glory.

FROGMORE RACES.

THESE races came off on Monday last, and were attended by a large number of persons, the majority of whom expressed considerable disappointment at the unsatisfactory manner in which the racing was conducted. Not a single event created the slightest interest; and the two principal events on the programme resulted in a walk-over in each instance, only one horse having been entered. The meeting, however, was far more orderly than had been generally anticipated, very few of those present displaying the pugnacious propensities with which they have hitherto been credited.

We append the result of the several events:—

1ST RACE.

The MAIDEN PLATE of £10,—For all horses that never won an advertised prize; weight for age; one mile and a half.

Mr. T. J. Ryan's Dora 1

Three horses started for this event, which was won with comparative ease by Dora.

2ND RACE.

PONY RACE of £5,—For all ponies, not exceeding 14 hands high, carrying 7 stone; mile heats.

This prize was carried off by a bay pony belonging to Mr. T. J. Ryan.

3RD RACE.

FROGMORE HANDICAP of £15,—For all horses, to be handicapped by the stewards, or whom they may appoint; 3 miles.

Mr. H. O'Neill's Dynamite, the only horse entered for this event, cantered round for the money.

4TH RACE.

MINERS' PURSE of £5,—For all horses, the bona fide property for the last 3 months of men employed on the Frogmore Copper Mines; 2 miles; owners to ride; post entrance.

Two horses came to the post to contest this event, and the peculiar manner in which one of them was ridden created considerable amusement. The two horses kept together for about a mile, when one of them pulled up. Mr. P. Malone's horse traversed the remainder of the distance alone, and was declared the winner.

5TH RACE.

PUBLICANS' PURSE of £7,—For all horses, to be handicapped by the stewards, or whom they may appoint (the winner of the Frogmore Handicap to carry 7lbs extra); 2 miles.

This was a walk-over for Mr. H. O'Neill's Dynamite; but owing to some trivial dispute

4th Race.

Miners' Purse of £5, — For all horses, the bonafide property for the last 3 months of men employed on the Frogmore Copper Mines; 2 miles; owners to ride; post entrance.

Two horses came to the post to contest this event, and the peculiar manner in which one of them was ridden created considerable amusement.

The two horses kept together for about a mile, when one of them pulled up.

Mr. P. Malone's horse traversed the remainder of the distance alone, and was declared the winner.

A series of events in 1877, led to the welcoming of an important lady as a new resident in the Village of Frogmore.

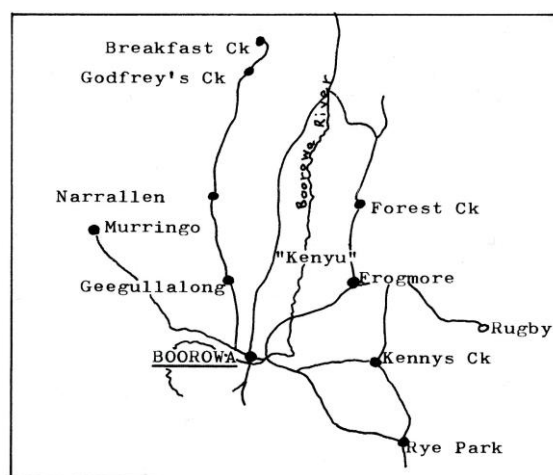
Patrick Thomas Malone had apparently been living in the village for a couple of years and as per the previous newspaper clipping was in the employment of the Frogmore Copper Mine.

When Patrick Thomas Malone arrived in the Frogmore District in 1864, he would have already had contact with Jenkin and Mary Morgan and their children, through the association with the Chisholm family of “Kippilaw” Goulburn and their vast pastoral interests between the Goulburn district and the Boorowa district.

By 1877 most of the Morgan children were already married (or soon to be married) and some of the female children had married and moved out of the district with their partner and families.

Sudden Death of Jenkin Morgan

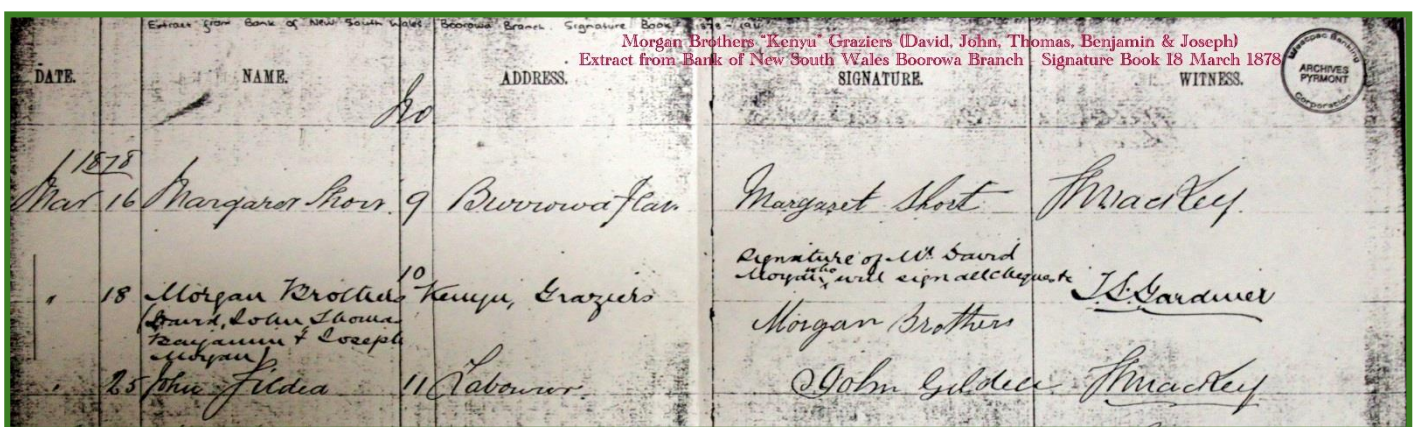
Apparently Jenkin Morgan had planned to go to Burrowa to make his will.

On Tuesday, 20 February 1877, Jenkin had been attended to by Mr Row the Boorowa Chemist. Jenkin had been suffering from urine retention for a period of 10 years.

The following day, Wednesday 21 February 1877, Jenkin was to collapse and **die** at his property "Glenavon", Frogmore, without ever making his will. Jenkin was just 59 years of age.

Jenkin had intended to leave the property "Kenyu" to his three sons who were currently working on the property, Benjamin, Thomas and Joseph Morgan. However, as a result of there being **no will**, the property was to be divided equally among **all members of the family**.

Apparently the **three** sons had to borrow heavily to buy the others out, although the document below lists all **five** sons as the Morgan Brothers, Graziers of Kenyu, David, John, Thomas, Benjamin and Joseph Morgan.

Marriage of Patrick Thomas Malone and Sarah Morgan

It was not until after the death of Sarah Morgan's father, Jenkin, in 1877 that Patrick Thomas, now aged 34 years, was able to take Sarah Morgan as his bride.

Sarah had just turned 21 years and was living at "Glenavon" with her widowed mother, when her marriage to Patrick Thomas took place.



The marriage ceremony took place at St. John's (Church of England) Church, Boorowa on 10th October, 1877.

Witnesses at the marriage were Sarah's brother and sister, John Morgan and Elizabeth Morgan.

Apparently there was quite a deal of **opposition** to the friendship of Patrick Thomas Malone and Sarah Morgan.

- Was it Patrick Thomas's Irish convict background?
- Was it the age difference between the two – Sarah was just 20 years Patrick was 33 year?
- Was religious difference a barrier? Patrick was Catholic, the Morgans were Methodists?

Patrick Thomas and new wife Sarah, after marrying in 1877, moved into residence in the village of Frogmore. The nearest township, Boorowa, was approximately 17 miles (27 km) away.

Frogmore Residence of Patrick Thomas and Sarah Malone

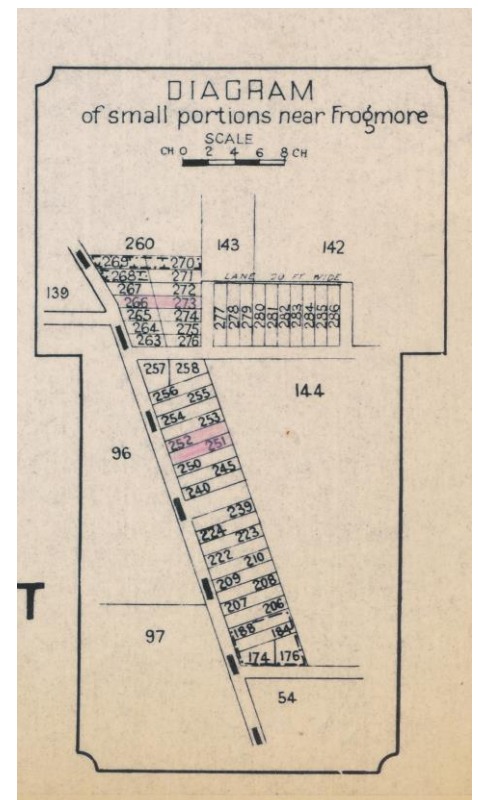
At their first Frogmore residence, conditions that Patrick, Sarah and their family lived under were quite primitive.

Because of no permanent water supply, tales were often told of ashes from the fire being thrown into a waterhole after fowls and pigs had been wallowing.

The ashes were used to settle the mud enough for household washing.

As in the map sections below, Patrick and Sarah Malone occupied Portion 251 of the Frogmore village allotment. (Eventually their son *Herbert Lester Malone* was to acquire the neighbouring allotment No: 252, while another son *Frank Malone* was to acquire two further portions in the village.)

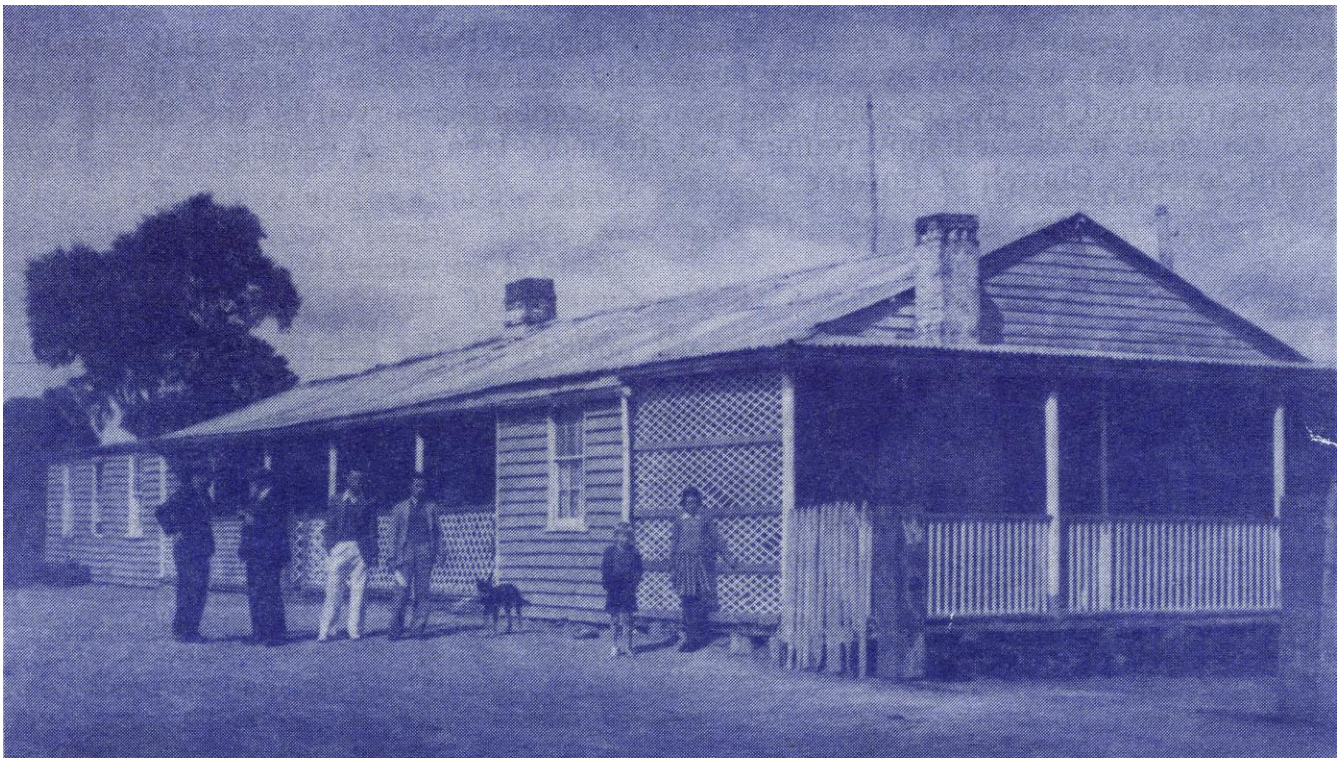
After the initial setback of losing their first child, Patrick and Sarah produced a further nine children.

Children were born to Patrick and Sarah over a period of 22 years. On the arrival of their **last child**, Sarah was aged 45 years and Patrick was aged 58 years.

Listings in 1878 and 1879 indicate that Patrick Thomas had gone into partnership in the Frogmore butcher's shop, providing meat for the hundreds employed gouging copper from the 1300ft. (430 metre) deep **Frogmore Copper Mine**.

Patrick Thomas Malone – Frogmore Poundkeeper

After disposing of the butcher's shop (possibly around 1880), Patrick Thomas Malone worked on different properties in the district and also as the Frogmore **poundkeeper**.

A poundkeeper like Patrick Thomas Malone:

- was appointed by the Bench of Magistrates at the local Frogmore Police Office/Courthouse. The Court of Petty Sessions opened at Frogmore on 21 October 1882, with Captain Fisher presiding once a month, a portable gaol was also supplied. (*Boorowa – Over 160 Years of White Settlement by Helen Lloyd*)
- The following 2 Government Gazette notices show an appointment for Patrick Malone as Poundkeeper at Frogmore to cover the period 1896 and beyond past 1899.

- *caring for (feeding and watering) of impounded stock*

- *furnishing to the Clerk of Petty Sessions a transcript from the pound book of the previous month and remit the remainder of the pound proceeds and other charges authorised*

Patrick Thomas Malone – Frogmore Poundkeeper

P.MALONE, Poundkeeper was a common entry in the NSW Government Gazette from 1896 until 1917 (a period of just under 20 years) – a testament to his skill and integrity.

Patrick Thomas Malone – The Latter Years

Patrick was also quite a handy **bush carpenter** and is believed to have been engaged in coffin building. Diphtheria epidemics meant a demand for small children's coffins. (Boorowa Court House records, on many occasions, show Patrick as the witness to many of the Frogmore district funerals).

According to Patrick's obituary, he possessed a quiet and unassuming character, and was a very respectable citizen enjoying a wide circle of friends in the district.

Patrick could speak reminiscently of the early days in the district and had often encountered bushrangers who were marauding the district in those days.

Family memories of Patrick in his retirement days include; bearded Patrick sitting on a chair on the verandah of his Frogmore house:

- *daily "bubble and squeak" (fried potatoes) breakfast, covered liberally with black pepper, black tea with lots of sugar, as well as chopped tobacco (Patrick's tobacco cutter and walking stick were in my possession, preserved for the family – at the recent Malone Reunion at "Orizaba", Murringo, these items were among the 'memorabilia dispersal ballot' and have new owners/caretakers).*

Death of Patrick Thomas Malone

On the 17th October 1928, Patrick Thomas Malone died at Frogmore. Patrick died aged **85 years** (*86 years on the death certificate is an error.*) Patrick died of natural causes, senile decay accelerated by bronchitis.

Rev. Father Bugler conducted the funeral service and Patrick Thomas Malone was buried in the Catholic cemetery, Frogmore by funeral director O. J. Stuart.

Apparently Patrick was persuaded before he died to return to his Catholic faith by his step sister-in-law Mary Ann Smith (former wife of John Jones), who was then residing at Cowra.

Patrick was buried next to his half-brother, former workmate and business partner John Jones.

PATRICK MALONE - died October 17, 1928.

The death of Mr. Patrick Malone took place at his residence in Frogmore. The late Mr. Malone, who was in his 86 th year, was a native of Goulburn and came to this district in the year 1864.

His step-brother, Mr John Jones was the manager of "Kenyu" Station at the time, on which property the late Mr. Malone found employment.

Ten years later he went to live at Frogmore, where he has resided ever since. The deceased was one of the original shareholders of the Frogmore Copper mine, but sold his interest to the Messrs. Deer Bros. He afterwards worked on different properties in the district and for a number of years has lived in retirement.

He was the Poundkeeper at Frogmore for many years. The deceased possessed a quiet and unassuming character, and was a very respectable citizen enjoying a wide circle of friends in the district.

Fifty-one years ago he married Miss Sarah Morgan, a member of the well-known "Kenyu" family, who survives him with a family of five sons and two daughters. One son, Walter was killed at the war. The surviving sons are: Frank, Herb, Tom, Harry and Jack, daughters Mrs. Jack Good and Mrs. Ben Roberts.

Mr. Malone could speak reminiscently of the early days in the district, and had often encountered bushrangers who were marauding the district in those days.

The funeral took place to the Catholic cemetery, Frogmore; Rev. Father Bugler conducting the burial service and the funeral arrangements being carried out by O.J. Stuart.

When Patrick Malone died in 1928, his wife Sarah was 70 years of age left to mourn her husband.

Sarah, who was quite a tall lady and especially in later years, became quite heavy, approximately 18 stone (115kg). Sarah was an easy going and happy person, although her granddaughter Kath Russell recalls being at the receiving end of some of Sarah's tongue lashings.

As she aged, Sarah fell now and again. Harry recalls that he would try to pick her up, but Sarah would break into fits of laughter, and she couldn't stop. Harry would also begin laughing and consequently had no hope of picking lifting Sarah, who in Harry's words ***“weighed a ton of bricks!”***

Sarah continued to reside at Frogmore after Patrick's death. For the last 5 months of her life, Sarah had been in ailing health and spent most of the time as an inmate of the Boorowa District Hospital.

Sarah Malone died on 28 March 1932. Her death certificate and headstone indicated she was aged 76 years ***(should be 75 years)***.

After a service conducted by Rev. G A Little, Sarah was buried in the Methodist portion of the Boorowa Cemetery by funeral director Mr O J Stuart.

Religious differences unfortunately saw Patrick Thomas Malone buried in the Catholic cemetery at Frogmore, while his wife Sarah was buried in the Methodist cemetery at Boorowa.

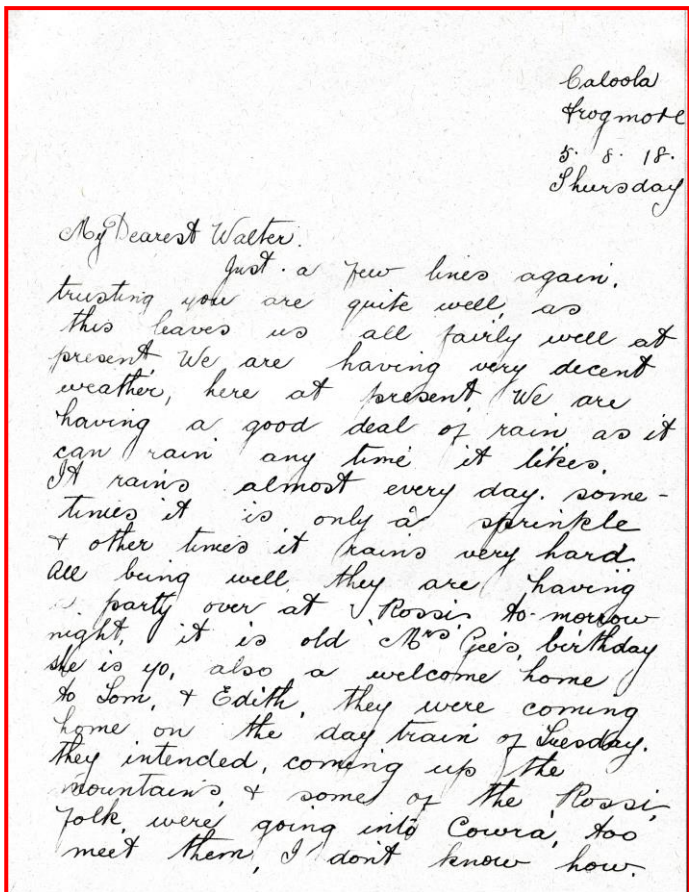
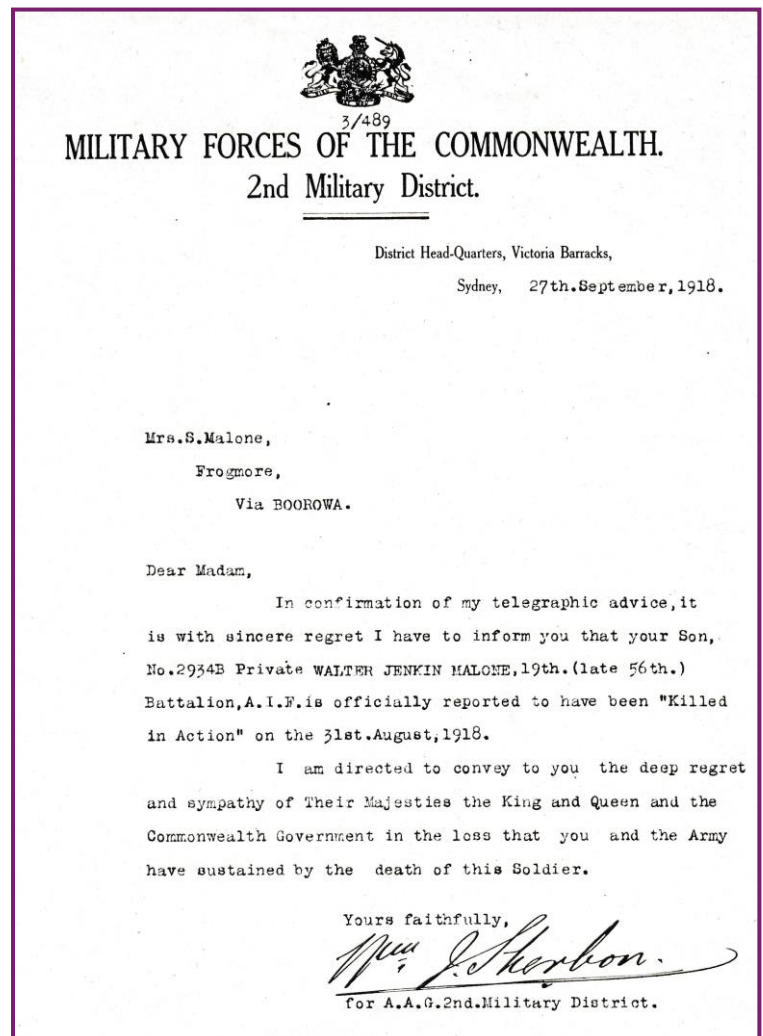
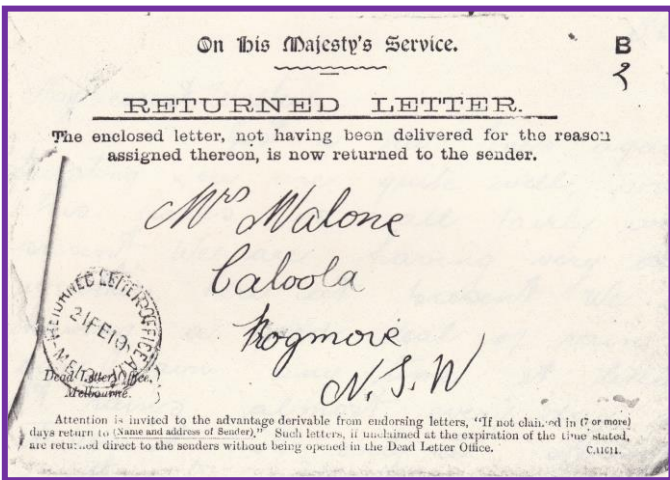

The **returned letter** “On His Majesty’s Service” (written by Sarah Malone to her son Walter) signalled the death of their son Walter on 31 August 1918, just as World War 1 was drawing to a close.

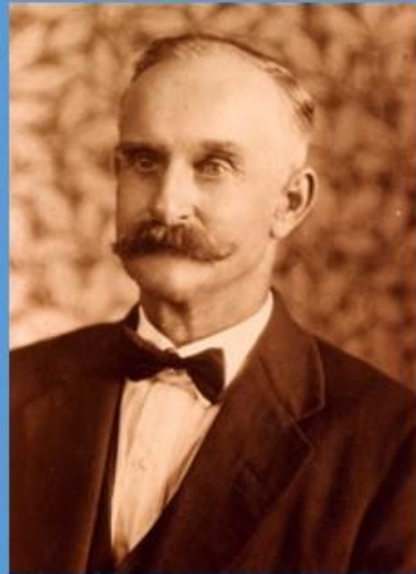

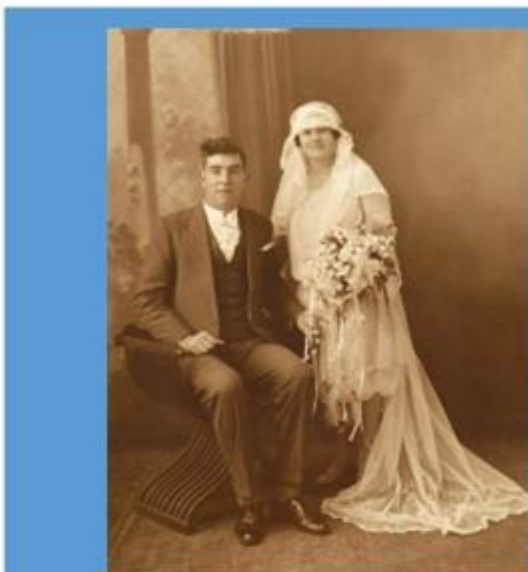

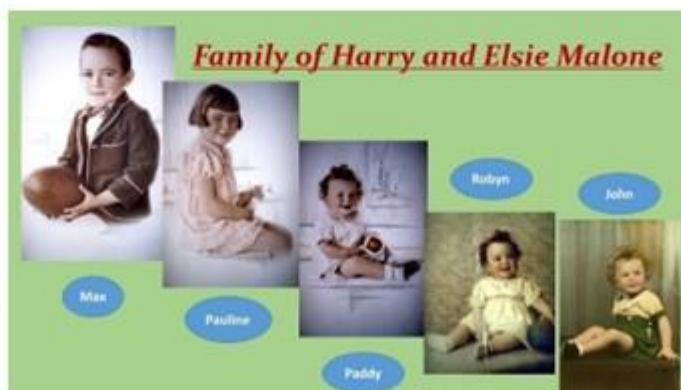
